

### OTOROHANGA DISTRICT LICENSING COMMITTEE

IN THE MATTER	the Sale and Supply of Alcohol Act 2012
<u>AND</u> IN THE MATTER	of an application by Otorohanga Club Incorporated for a special licence pursuant to section 138 of the Act

#### DECISION OF THE OTOROHANGA DISTRICT LICENSING COMMITTEE

- 1. The application for an on-site special licence is granted. The special licence may issue immediately.
- 2. Otorohanga Club Incorporated is authorised to sell and supply alcohol, on the premises situated at 107 Maniapoto Street, Otorohanga to any person attending the Steam Fest functions.
- 3. This licence is subject to the following conditions:
  - a) A copy of this licence with all the conditions must be displayed in a prominent place so all persons can read it and all staff must be familiar with the conditions.
  - b) Alcohol may be sold on the following days and during the following times:

Steam Fest Craft Beer and Wine Tasting and Band "Kingston Flyer"

Saturday 19 August 2017, from 5.00pm to 12.00 midnight

Champagne Brunch Reunion for Train and Railway Staff

Sunday 20 August 2017, from 11.00am to 2.00pm

- c) Alcohol may be sold or supplied to people present participating in the events this licence is issued for.
- d) The area where alcohol is to be sold and consumed is described in the plan date stamped as received by the Otorohanga District Licensing Committee on 24 July 2017 and no alcohol is to be taken out of this area.
- e) The entire premises is undesignated.
- f) The holder of a manager's certificate shall be on duty and on the premises at all times alcohol is sold. A sign shall be displayed identify the duty manager.

- g) The licensee must ensure compliance with the Host Responsibility Policy submitted with the application and must ensure all staff receive training in their responsibilities and obligations under the Act.
- h) There must be no sale or supply of alcohol to minors or intoxicated persons and there must be displayed at every point of sale appropriate signs detailing these restrictions.
- i) Drinking water must be freely available from the bar and this must be clear to customers, while the premises is open for the sale and supply of alcohol.
- j) Food must be available for consumption on the premises in accordance with the menu submitted with the application for this licence, or variations of a similar range and standard. Menus and the availability of food should be clear to customers and food should be actively promoted.
- k) A range of low-alcohol and non-alcoholic drinks must be available at all times when the premises is open for the sale of alcohol.
- A telephone must be freely available for customers to call for transport and staff must assist if required. Telephone numbers for alternative forms of transport from the premises must be displayed. The availability of the courtesy van to transport patrons home from the premises shall be promoted.
- m) No BYO alcohol on the premises while alcohol is available for sale.

## REASONS

- 1. This is an application by Otorohanga Club Incorporated for a special licence for the Steam Fest functions to be held at their premises. The application was filed more than 20 working days prior to the event as required by section 137 of the Act.
- 2. The Licensing Inspector, Police and Medical Officer of Health have no objection to this application for a special licence (s 141). Accordingly, this application is decided on the papers (s 202).
- 3. The purpose of the Sale and Supply of Alcohol Act 2012 (the Act) is to put in place a new system of control over the sale and supply of alcohol (s 3). The object of the Act is to ensure that the sale and supply of alcohol is undertaken safely and responsibly and the harm caused by excessive or inappropriate consumption of alcohol is minimised (s 4).
- 4. In deciding whether to grant a special licence the District Licensing Committee must have regard to the criteria in s 142 of the Act. Therefore this committee must consider the following questions within the framework of the purpose and object of the Act:

a) What is the nature of the event? Does the applicant propose to engage in the sale of goods or provision of services other than those directly relating to the sale of alcohol, low-alcohol refreshments, non-alcoholic refreshments and food?

b) Is the applicant suitable?

c) Will the amenity and good order of the locality be reduced to more than a minor extent by the effects of the issue of the licence?

d) Are the days and hours during which the applicant proposes to sell alcohol reasonable?e) Is the design and layout of the premises suitable? Are any areas of the premises designated restricted or supervised areas?

f) Does the applicant have appropriate systems, staff and training to comply with the law? What steps will the applicant take to ensure that alcohol is not sold to prohibited persons?

g) What proposals does the applicant have in relation to the sale and supply of non-alcoholic drinks and food, low-alcohol drinks and the provision of help with or information about alternative forms of transport from the premises?

h) Have the Inspector, Police and Medical Officer of Health raised any relevant considerations? i) Does the application comply with the Otorohanga District Local Alcohol Policy?

5. The licensing committee may refuse a special licence even if there was no objection to the application (s 144). Sections 146 – 149 of the Act outline the compulsory and discretionary conditions for a special licence.

# Should a special licence be granted?

- 6. Over the weekend of the 19<sup>th</sup> and 20<sup>th</sup> August 2017, the township of Otorohanga hosts "Steam Fest", a festival celebrating the Golden Era of Steam, Vintage, Heritage and People. The festival includes train rides, vintage tractor and car displays. As part of the festival, Otorohanga Club is planning to host two events. The first is a craft beer and wine tasting and a performance by the train themed "Kingston Flyer Band". The second is a champagne brunch as part of a reunion for the town's former train and railway employees. The Steam Fest website confirms that the Otorohanga Club's carpark will be used for displays.
- 7. The licensing committee is satisfied that Otorohanga Club Incorporated is a suitable applicant to hold a special licence. The club currently holds a club licence and has demonstrated compliance with the Sale and Supply of Alcohol Act 2012. The issue of a special licence for this event will allow the applicant to sell alcohol to non-members of the club attending the event. A Duty Manager will be present on the premises for the duration of the proposed event to ensure compliance with the Act. The licensing committee is satisfied that the proposed hours are reasonable.
- 8. The licensing committee is satisfied that suitable measures will be taken to ensure that alcohol is sold and supplied responsibly and that harm caused by inappropriate or excessive consumption of alcohol is minimised. Given the nature of the event and the venue it is not likely that the issue of the special licence will adversely affect neighbouring properties.
- 9. The application is compliant with the Otorohanga District Local Alcohol Policy.
- 10. The licensing committee is satisfied that the design and layout of the premises is suitable given the temporary nature of the licence. The applicant will provide sufficient food, low-alcohol and non-alcoholic refreshments. Free water will be provided. A courtesy vehicle will be available to transport patrons home is required.

# Conclusion

- 11. The licensing committee is satisfied that the grant of the special licence with the appropriate conditions will ensure the safe and responsible supply of alcohol and the minimisation of harm caused by excessive or inappropriate use of alcohol.
- 12. Therefore, the application for a special licence is granted.
