ŌDC's Manager Community Development & Wellbeing, Nicky Deeley, spoke to the staff report. She then led the Committee through each individual application where the Committee reviewed the individual scores and the average of those scores. The Committee indicated their preferred funding for each application. In accordance with his Declaration, Councillor Dow abstained from the deliberations for the

Ōtorohanga Carriers Association application and left the meeting at 7.01pm and returned at 7.06pm once the discussions were completed.

Deputy Chairperson Tamaki led the Committee through a review of the applications as a group and the Committee finalised each grant.
