Item 39 – Tom French Reserve – Proposed Installation of Security Camera

ŌDC's Jared le Fleming, Manager Community Facilities outlined the main points noting the recent reduction in boy racer activity. Councillor Jeffries queried if staff had discussed cost sharing with Tainui Kāwhia Incorporated (TKI) for a camera on Te Puia Road. He then queried the monitoring and maintenance of the cameras in the Kāwhia township. Mr le Fleming advised discussions had not been held with TKI to date. He advised the township cameras were repaired when issues arise and a project was underway to connect the cameras via the Kāwhia Community Centre's Starlink connection to provide live monitoring ability to the NZ Police.

Board Member Walsh noted the Tom French Reserve was outside the Kāwhia Community Board area and Chairperson Good confirmed the Board could only make a recommendation to Ōtorohanga District Council.

Resolved K129: That Kāwhia Community Board receive the report and recommend the incoming Board revisit the need for a camera in March 2026 as part of the Annual Plan process.
