THE APPLICATION

The Otorohanga District Licensing Committee has before it an application by Kawhia Boating and Angling Club Incorporated an *on-site* special licence pursuant to section 137 of the Act.

The events leading to this application are to be held at 124 Omimiti Street, Kawhia and can be summarised as follows:

- Thursday 24 November 2016 'Kasha Snapper Fishing Competition', from 3 p.m. to 1 a.m. the following day for 90 people of various ages.
- Friday 25 November 2016 'Kasha Snapper Fishing Competition' from 3 p.m. to 1 a.m. the following day for 90 people of various ages.
- Saturday 26 November 2016 'Kasha Snapper Fishing Competition' from 3 p.m. to 1 a.m. the following day for 90 people of various ages.
- Saturday 31 December 2016 'Band Tenfoot leap' from 3 p.m. to 1 a.m. the following day for 90 people of various ages.
- Sunday 1 January 2017 'Kawhia Whaleboat Rowing' from 3 p.m. to 1 a.m. the following day for 70 people of various ages.
- Saturday 28 January 2017 'Sweepstake Fishing Competition' from 3 p.m. to 1 a.m. the following day for 40 people of various ages.
- Sunday 29 January 2017 'Sweepstake Fishing Competition' from 3 p.m. to 1 a.m. the following day for 40 people of various ages.
- Saturday 4 February 2017 'Off the Beach Fishing Competition' from 3 p.m. to 1 a.m. the following day for 50 people of various ages.
- Thursday 2 March 2017 'Quota Club Fishing Competition' from 3 p.m. to 1 a.m. the following day for 90 people of various ages.

- Friday 3 March 2017 'Quota Club Fishing Competition' from 3 p.m. to 1 a.m. the following day for 90 people of various ages.
- Saturday 4 March 2017 'Quota Club Fishing Competition' from 3 p.m. to 1 a.m. the following day for 90 people of various ages.
- Saturday 11 March 2017 'Wedding of Daniel Spencer and Delwyn Philips' from 3p.m. to 1 a.m. the following day for 60 people of various ages.

The events are not considered to be large scale events in accordance with section 143 of the Act.

DECISION OF THE COMMITTEE

No objections have been filed in respect to this application pursuant to section 140 of the Act, and it is therefore determined on the papers by the Chairperson alone in accordance with section 191(2) of the Act.

Reports have been received from the Police, the Medical Officer of Health and a Licensing Inspector. No concerns have been raised in respect to the criteria outlined in section 142 of the Act.

There is no information to question the applicants suitability, and it is felt they have appropriate systems, staff and training in place to comply with the law. This, combined with the design of the intended premises, and the availability of food, low and non-alcoholic beverages leads to the conclusion that there is unlikely to be any negative effect on the amenity and good order of the area, and that ultimately the application satisfies the object of the Act.

However, in order to ensure that is the case a number of conditons have been recommended in respect to the application. Namely:

- a) Alcohol sold/supplied to the following types of people: Those attending the events only.
- b) The fees payable for the licence concerned are: \$207.00
- c) Steps to ensure that the provisions of this Act relating to the sale and supply of alcohol to prohibited persons.
- d) Steps to ensure that the provisions of this Act relating to the management of premises.
- e) **Drinking water must be freely available at the following places while the premises are open for business:** The Bar
- f) Food must be as follows:
The food provided for the event will be as described in the bistro menu and smorgasbord menu or food that is similarly substantial.
- g) Low alcohol beverages must be available as follows: low alcohol beer such as Peachees and Light Ice.
- h) Non-alcohol beverages must be available as follows: tea coffee, juices and soft drinks.
- i) Provide assistance with or information about alternative forms of transport from the premises.
- j) A certified duty manager is to be available and on site during each event.

Having due regard to the application and the reports received, the application is hereby approved, subject to the above conditions. The special licence may be issued immediately, and shall remain in force until the conclusion of the final event as detailed in condition a) above.
